
Support the development of the concept note

NSP ready by end of 2014



- Descriptive map is helping the country to understand the gaps in surveillance system
- Risk map will be used in NSP to determine interventions
 - There is the need to produce a risk map (first one in the country) to better target elimination interventions

CHAI started modeling information from MoH and other main partners

- Data level as of municipalities
- Small % of data at case management level
- Gap in georeferentiation at community level

- Road map for a refined risk map will be produced
